- Live area should be set at least 1/4" safety from trim on all sides. Allow 1/8" gutter safety for spread ads.
- All files used must be high-resolution (300 dpi or higher).
- If scans are reduced more than 50% should be reduced in Photoshop.
- We print in CMYK and adhere to SWOP specifications

FILES (locked)

- We accept PDF and DCS2 files
- Spreads must be saved as two single-page files
- Document must be linked to the most up-to-date graphics, fonts, logos, etc
- A proof **MUST** be enclosed with the disk/cd (see "PROOFS" below)
- Include a print-out of the contents window of the disk/cd

PROOFS

- All color ads must be sent with a proof suitable for use on press. If you are unsure of what type of proof is acceptable, contact your traffic department representative and ask to be connected to the production department. **PSP is not responsible for color if a suitable proof is not supplied.**
- All black-and-white ads must have a laser proof supplied
- If the finished document does not match the color proof exactly, the color proof should be marked "For Color Only" and a laser of the actual ad should be provided.

MEDIA

- Ads should be sent on CD Rom. If you have a different type of drive, please contact your traffic representative and ask to be connected to the production department
- All files received must be final; PSP is not responsible for grammatical or punctuation errors, etc.
- Ship all materials to address listed below, ATTN: David Brochu. Send all materials by FedEx or other traceable shipping methods to ensure safe delivery.
